TG [REDACTED] SU1 RW W/D target area. TG [REDACTED] The [REDACTED] note suspicious activity [REDACTED] Details of Entry Procedure on the RED compound and the guest house. The door on the guest house is locked from the inside. TG [REDACTED] Cordon set. Call out on guest house commences. There is no response.

TG [REDACTED] Entry on the guest house. As the lead call sign enter the guest house they are confronted with 3 Bs who move to engage them. The Bs pose an immediate threat to life and are engaged with aimed shots resulting in 3 EKIA.

TG [REDACTED] Entry on RED compound.

TG [REDACTED] APU1 lead call out on the RED compound commences.

TG [REDACTED] 1 B leaves the main building of the RED compound. The [REDACTED] instruct him to get all personnel out of the building.

TG [REDACTED] Es and Ks leave the building.

TG [REDACTED] A further B leaves the building.

TG [REDACTED] 1 B moves back into the main building of the RED compound to open the windows and doors.

TG [REDACTED] Call sign moves into the main building. It is reported clear and SSE is conducted.

TG [REDACTED] Initial TQ reports that the 3 EKIA had tried to steal food from the RED compound and subsequently locked themselves in the guest house.

TG [REDACTED] Slant on RED compound is confirmed as 2/2/6.

TG [REDACTED] SU1 C/S moves in to check a suspect device. It is reported clear.

TG [REDACTED] 3 EKIA all test positive for HME. 2 AK 47 (60 rounds), [REDACTED] Personal property and DOCEX are recovered from the RED compound.

TG [REDACTED] Air Assest engages [REDACTED] location S of the RED compound.

TG [REDACTED] Air Assest engages [REDACTED] location N of the RED compound.

TG [REDACTED] SU1 move to the GREEN compound. 1 B is detained from the RED compound.

TG [REDACTED] The door to the GREEN guesthouse is also locked from the inside. [REDACTED] Details of Entry Procedure GREEN guest house. Call out commences. There is no response.

TG [REDACTED] After [REDACTED] Entry the lead call sign enters the guest house and they are confronted by 3 Bs who move to engage them. They pose an immediate threat and are engaged with aimed shots resulting in 3 EKIA.

TG [REDACTED] APU1 lead call out commences on the GREEN compound. 1 E opens the gate.

TG [REDACTED] Es and Ks leave the building. The slant is confirmed as 0/7/13.

TG [REDACTED] SSE on GREEN compound. 3 EKIA test positive for HME. [REDACTED] Personal property DOCEX and 1 AK 47 (30 rounds) are found.

TG [REDACTED] Call sign reports the GREEN compound is clear and secure.

TG [REDACTED] 3 Bs detained off the GREEN compound. [REDACTED] SU1 move to exfil HLS with 4 Bs to be detained off site.

TG [REDACTED] All call signs at exfil HLS. TG [REDACTED] SU1 RW W/U.

TG [REDACTED] TFH was given full SITREP and a BSHO was completed verbally. Final Slant: 5/9/19, 4 x Detainees, 6 x EKIA (all 6 x EKIA tested positive on SEEK). No CIVCAS. SSE [REDACTED] Personal property / DOCEX/AK Variants and ammo/ [REDACTED]
