



N1803 - Assistant Chief of Staff Policy (Acos Pol) at HO DSF. was responsible for advising on matters of poliny regarding UKSF operations and ensuing these operations were in ausidance with Government Policy, whilst Seeking authority from the Secretary of State for defence. Liased wien operations Directorate (op sir) and Central Legal Service and Foreign and Commonwealth office and DSF Command Group. Engaged with Cos, N2252, and DSF, N1802, on a daily basis Also briefed ops Oir, N2312. Whilst at DSF, read reports generated by unof deployed on operations and would raise vives with either CoSor OSF or seriors in MOD. Had a subordinate employed in ups room who had access to the routine reporting of UKSF operations. Regularly read Significant Insident Reports (SINCREPS) generated by Sr Sub-Unit in Afghanistur Recalls becoming Concerned about a Taurie, Technique and Procedure (TTP) which was being used by an SF unit. This would involve SF unit taking an adult male detance back into the Compaind. Believed this was to assist Searching process. In a few Sincreps, it described how personell would take a detainer back into the building, to derisk the process of Searchy Detainer described as reaching for weapon and shot and killed as they were perceived as a threat. Saw this more than once.

Said TTP prompted the asking of questions of ux's responsibility to detainers. Spoke to Soi Campaigns. N1788 and ACOS Ops, N1466 who Contacted the to understand arcunstances. Found response reasonable and plausable however viewed that action should be taken to prevent Similar Circumstances recurring. Noticed Similar incidents had happened, had further Conversations with N1466 and N1788 escoressing Conver. Specific Conversation in NI466's office when he then Spoke to NIVOZ regarding insidents. NIBOZ asked NI788 to go to Afghanistan to Conduct a TTP review. Can't recall attending any meeting in relation to the TTP review prior to N1788's departure, during or open his return. Did not see report upon return either. Upon Conduction of the TTP review, underto Stopped Carner Confirm if this was as a result of the review. Doesn't recall any Correspondance from a Third Party Entity
