		<p>TG Two Bs are sent to pull down the curtains and open the doors. As they enter the building they move into fire positions and attempt to engage the call signs in the courtyard with one AK47. They pose an immediate threat and are engaged by the Cover Men covering the courtyard resulting in two EKIA. A further B, previously squatting by the building and ignoring the call out, immediately grasps the downed AK47 and moves to engage the call signs in the courtyard. He poses an immediate threat and is engaged with aimed shots by the one of the call signs in close proximity resulting in one EKIA.</p> <p>TG Call signs move into Compound 68. On entry, they are confronted by a further armed B. He moves from behind a door and draws his weapon. He is engaged by the lead call sign resulting in one EKIA.</p> <p>TG Compound 68 reported clear and secure – the slant is three Bs, three Es and seven Ks. Two Bs are detained off site. SSE recovers Personal property and DOCEX.</p> <p>TG The APU1 led call out on Compound 69 commences.</p> <p>TG No response Details of entry procedure. 29	REMARKS	<p>OC's COMMENTS:</p> <p>This was a successful operation that involved a considerable amount of [] Target Development (TD) in order to ascertain the target Pattern of Life (PoL) and Bed Down Location (BDL). The operation was conducted in an area notorious for its inhospitality toward ISAF and resulted in eight EKIA and nine detainees from both the Compound of Interest (CoI) and several associated compounds.
