

The operation appears to have been a success; all 6 EKIA tested positive for HME and [REDACTED] Personal property [REDACTED] recovered from the GREEN compound has already been linked to [REDACTED] Obj QA [REDACTED] and his [REDACTED] HEL attack network. [REDACTED] We wait to see if Obj QA was one of the EKIA [REDACTED] or one of the detainees [REDACTED].
