I acknowledge your concern. Clearly, we need to be careful in questioning tactical actions in which we were not involved - however, I do not believe there is anything wrong in the TTP per se. I have seen it work successfully in both LG (Not A) and Afg hundreds of times, without requiring shots being fired. The efficacy of execution is a quite different matter, but we would need to know more about the individual circumstances of each op.

The HQ would have to take a view on whether there is a justification here for intervention - which should only be done in extremis. However, the Dir may well have a view - he mentioned the comparison between SFHQ(A) KIA stats and PF1s last week.
