- 10. Again, there is nothing that I wish add to the commentary I offered in on NWS/14A, save for clarifying that I did not create NWS/14A and this was not the document upon which I based my review. At the time I was asked to perform my review, my role as SO2 Operations (A) consisted of reviewing the OPSUMs for all UKSF operations globally. I therefore would have had my own direct access to the OPSUMs I reviewed.
